

#### Main case

 Both the counsel have prayed for disposal of this petition itself at this stage, as the only point involved in the present case is whether the respondents had given a fair opportunity to the petitioner to submit the C and F forms which had been issued by the concerned authorities of respective States to him.

- 2. Learned counsel submits that on account of wrong e-mail id, the case of the petitioner could not be taken up in the correct format.
- 3. Learned counsel appearing for the State submits that he has instructions that if the petitioner submits the C and F forms within a stipulated period, the case of the petitioner shall be re-examined and appropriate orders shall be passed accordingly.
- 4. We appreciate the stand taken by the State, which goes a long way to dispose of litigation at the initial stage itself.
- 5. We accordingly allow the writ petition and direct the respondents to accept the C and F forms as available with the petitioner, and after verification pass appropriate orders afresh. The impugned orders dated 15.11.2022 and 19.10.2023 are quashed and set aside with aforesaid liberty. Exercise may be conducted within a period of two months henceforth, provided the petitioner submits and deposits the C and F forms within a period of 15 days.
- 6. Writ Petition stands allowed with aforesaid directions.
- 7. All pending applications also stand disposed of accordingly.
